COMMISSION ON THE STATUS OF WOMEN: DIASPORAS IN HONOR!

Brussels, 8 March 2019 - A delegation composed of the Forum des Organisations de Solidarité Internationale issues des Migrations [FORIM], Women and Contributions to Development [FECODEV] and the Africa-Europe Diaspora Development Platform [ADEPT] will participate in the sixty-third session of the Commission on the Status of Women taking place at the United Nations Headquarters in New York from 11 to 22 March 2019. The delegation will organize a side event on 'Gender, Migration and Development: actions and partnerships for effective social protection' on Tuesday, March 19, 2019, at 4:30 pm EST, at the Church Center for the United Nations (777 United Nations Plaza, NY, corner of 1st Avenue & 44th Street).

Nearly half of the world's 258 million migrants¹ are women who increasingly migrate independently using their skills, knowledge and financial contribution to support themselves and their families, while contributing substantially to the development of their home and host countries.

In a context where gender inequality persists, migrant women face double discrimination in terms of access to education, decent employment, housing or health services. While taking into account the intersections between the multiple forms of discrimination experienced by migrant women is still tenuous in the development and implementation of migration and development policies, it is now clear that the achievement of the Objective 5 of Sustainable Development on gender equality is a *sine qua non* condition for the achievement of other SDGs, as well as of the Global Compact for Migration.

Organized as part of CSW63 by FORIM, FECODEV and ADEPT, the side event will shed light on the migrant women access to social protection, how to reduce vulnerability factors and guarantee the transferability of migrant rights. Through civil society organisations' testimonies, international organizations' programmes presentation and sharing of the good diaspora engagement practices the event will aim at developing effective partnerships and multi-stakeholder cooperation programmes enabling to ensure that migrant women benefit from their rights and act as agents of development and positive social change.
